MEMBERSHIP DESIGNATIONS

FULL GOLF (Resident).....

Initiation Fee: \$1,000 | Dues: \$250 per month

A Full Golf membership provides access to all of the Club’s facilities for the Member and their immediate family. These facilities comprise of the Pinnacle Golf Club’s 18-hole championship golf course, driving range, and golf practice areas, as well as the fitness center, tennis courts, resort-style swimming pool, and clubhouse facilities with all associated social activities. Members can book tee times up to 10 days beforehand, and they won’t be charged for greens fees or tennis court fees. Cart fees are the only additional charge if members choose to ride.

FULL GOLF (Non-Resident).....

Initiation Fee: \$1,000 | Dues: \$280 per month | Includes Golf Cart

This designation applies to Members that do not live in the Pinnacle Community who will enjoy identical privileges to those of our Full Golf Members, except they can book tee times up to 10 days beforehand.

JUNIOR GOLF (Resident / Non-Resident) (AGE 21 - 35).....

Initiation Fee: \$500 Dues: \$210 per month | Includes Golf Cart

Junior membership is open to individuals aged 35 or younger, and it includes the Member and their immediate family with access to all Club amenities. Members with this designation will receive the same benefits as our Full Golf Members and, on their 36th birthday, will be automatically upgraded to full golf designation without any additional initiation fee, provided they maintain their golf membership.

SOCIAL (Non-Resident).....

Initiation Fee: \$250 | Dues: \$150 per month

A Social membership grants access to all Club amenities except golf for the Member and their immediate family. These amenities comprise the fitness center, tennis courts, resort-style swimming pool, and clubhouse facilities with all social activities. Social Members may also play up to two rounds of golf per month by paying a guest fee, and they have the option of adding an unlimited driving range privilege to their membership.

Individual Range Plan: \$250 a year or Family Range Plan: \$350 a year
